ELIGIBLE

Children from multicultural families **aged 7 to 18 with income exceeding 50% and below 100% of the median income** who do not receive education benefits. (Korean Citizen)

※ Children who are not attending school can also apply

Support Details

Academic Activities: Purchase of textbooks to improve learning ability, support for reading room expenses, etc.

Career Activities: Certification support, purchase of materials for vocational training practice, etc.

- Elementary School 400,000 won per year for (ages 7 to 12)
- Middle school 500,000 won per year (13 to 15 years old)
- High school 600,000 won per year (16-18 years old)
(2006.1.1.~ 2017.12.31.)

How to Register

Applicant must prepare needed documents, and make reservation by phone at the Family Center, and apply personally.

Documents to be Submitted

1. Documents prepared by the applicant (Refer to Siheung City Family Center website announcement)

- Application for educational activity support expenses
- Educational activity cost utilization plan
- Confirmation of common-law marriage
(if Korean spouse and marriage immigrant do not register marriage)

2. Applicant's Required Documents

- Copy of rmResident Registration (listed on the copy of marriage immigrant or naturalized person)
- Family Relationship Certificate (Detailed)
- Alien Registration Card
- Basic Certificate (Detailed) (Married immigrants who have acquired nationality and cannot verify their alien registration card)
- Copy of Passport and Certificate of Entry and Exit (Subject to verification of foreign nationality)
- 2024 Health Insurance Premium Payment Confirmation (April)
- 2024 Health Insurance Status Confirmation (Notification)
- Copy of NH Nonghyup card

Submit one copy per adult household member

※Excluding NHBC Card, Subsidy Card, and Local Currency Card.

July (Applicants from 5/1 to 6/21),
September (Applicants from 7/1 to 8/23),
October (Applicants from 9/2 to 9/23)

Usage Procedure

1. Applicant must prepare needed documents, and make reservation by phone at the Family Center, and apply personally. (May to September)

2. Selection and notification of beneficiaries (individual notification scheduled)

3. NH Nonghyup Card card point payment (July, September, October)

4. Use of educational activity expenses (July to November/Card points cannot be used after November)
